Fight For The Light is WON!

On June 19th residents of District 5, Lee County, received a personal letter from Frank Mann, one of our County Commissioners, telling us that the long wait for a traffic light at State Road 31 (Babcock Road) and North River Road is being planned. Below is a copy of the letter we all received.

Thanks to all who petitioned and begged for this safety feature over the past several years.

Dear Neighbor,

Good news about the intersection at SR 31 and North River Road. The long hoped for traffic signal is on the way and should arrive in September. You may have been one of the residents that have been decorating your lawns with the little signs that say, "Fight For the Light". Well, you won the fight.

I drive that intersection every day, and no one knows how badly we've needed a signal there better than myself. If it were up to the county to have approved the light, it would have been there already. The problem causing the delay has been that North River Road is a County Road, but SR 31 is under State control. So we've had two agencies of government that had to agree on how and when to go about installing a light. My challenge was to get them all in the same room at the same time and work it out. The state had planned a light at that intersection for some time now, as part of the future widening of SR 31, but recent traffic counts would not justify their requirements for a light placement now. My point, and one all of us could see, was that traffic resulting from the heavy activity at Babcock Ranch, combined with construction activity at the new gas station about to open right at the intersection, was clearly making the location both slow and dangerous. Sadly, it took several recent accidents to help make our point of the need for the light.

Engineering studies are being completed right now, and equipment for construction is being ordered. These projects always take a little longer that we'd like, but help is indeed on the way. Thanks for your patience.

Two quiet parks for pandemic-safe picnics



Out east of Alva there are several places folk can go for nice safe and private picnics. Most of us on the Caloosahatchee know about the Franklin Lock Park near Riverdale, and Barron Park in LaBelle, each offering pleasant riverside picnic tables, and a few private roofed tables. However, two less known spots nearby need mentioned.



For a farm and country environment there is the Muse Playground at the Muse Fire Station at Loblolly Bay Road and Rainbow Boulevard (Don't you just love our wonderful street names?!). This is a LaBelle address but the park is located miles to the northeast of town, quiet and private most of the time.



Another park a bit closer to town and on the river is the Bob Mason Park that stretches multiple private shaded picnic sites and covered benches along the north bank of the Caloosahatchee and Rte 78. It's just west of the public docks and the LaBelle bridge. There are even public tie-ups for boats here as well.

The many old oaks, pines and palms make this

a perfect place to share a quiet picnic with the family, or just read a good book away from home for a change.



One local Episcopal Church deals with Pandemic (TY Caloosabelle)



It seems so long ago now. Weeks have passed into months. And still, while meeting together inside now, we still require social distancing, masks, and communion is no longer by the common cup.

The article below was published in the Caloosa Belle Newspaper on April 12th, 2020. I have republished it here at the request of the priest, Reverend Elizabeth L. Nelson, for readers interested in how one church, her small parish, Good Shepherd Episcopal Church, has dealt with, and is dealing with, our pandemic

All those things we treasure—prayer groups, Lenten studies, Stations of the Cross, the traditions of Palm Sunday, the glorious triumph of Easter complete with the fragrant smell of lilies filling the sanctuary—all of it has been taken away from us because of the Corona Virus. We have been forced into an everyday life of constant sacrifice, albeit not

because we are remembering the sacrifice of Jesus on the cross. We have no choice in the matter. Sacrifice has become the “new normal.”

These thoughts took me back to fourth grade—Holy Ghost Catholic School. I remember a Lenten poster of an enormous crown of thorns hanging on the chalk board. It was terrible to look at, but designed to make a point: Jesus wore this crown, experienced this much pain, because He loves us. And there was a task attached to this poster. Sister had a pad of rosebud stickers on her desk that came with a challenge: “If you go to Mass in the morning before you come to school, you can take one of these rose buds and stick it over one of the thorns in Jesus’ crown.” Well, that’s easy enough, I thought. I walked to school anyway and the church was right next door. An easy challenge...until it wasn’t. The first time I missed Mass, I sat there and watched as other kids put a rose bud on a thorn and I cried silently. I had disappointed Jesus, I thought, or worse yet, He might stop loving me.

Fast forward almost forty years. I had become an Episcopalian with a call to the priesthood, and I actually found myself at a function with the principal of that very grammar school! Awkward! I began to feel the same guilt I had felt as a child. She’s going to condemn me, I thought. As we talked I found myself saying that I didn’t know that God loved me until I was twenty-one years old. I noticed a tear in her eye, and she said, “We didn’t teach you that, did we?” That little, profound statement said it all.

God is love. What God has given us, what God has done for us, is all out of love. And He doesn’t give us rules and regulations to frighten us into submission. He doesn’t insist on any particular form of prayer and worship. He just wants us to return to Him and to each other what He’s given us...pure, unselfish, love! Look it up in 1 Corinthians 13. There is no greater love than this. It was never about covering thorns with stickers or following rules out of fear. It’s always been about love. And all those things you’ve had to sacrifice because of the virus? You now have more time for prayer, for talking with the One who has you and all the world in His loving arms. This current crisis will have an end. As for God...He is eternal, and His love is never-ending.



The Corbitt Hog Hunt

I Want to share a story with y'all about Archie Corbitt, my dad. My husband, Wayne Corbitt, was raised a little bit old-fashioned and I never will forget when he asked my dad if he could have my hand in marriage. It was 1974. Those of you who knew my dad knew he was a quiet, simple Man but he had a little bit of a stinker side too.

Dad was an avid hunter. When I could barely walk, maybe six years old, I went coon hunting with him and I would drag the sack and shine our light in the trees. It was just me and him. He'd get me out of bed in the middle of the night and I'd always be right there with him. He loved hunting many species but his biggest passion was hog hunting.

Back to my marriage story: My intended and I went over to his place on a Friday and dad was getting ready to go on a hog hunting trip. I forget who all was on that trip but I'm seemingly thinking that Donnie Handley was on this trip too. If I remember right there were several others along.

My father had a straight solemn face and looked at my husband and said, "You can marry my daughter if you'll go on this hog hunting trip with me this weekend in Corkscrew Swamp." My husband was raised a country boy, and he did some small game hunting when he was younger but wasn't a big animal hunter. Nonetheless he said, "Sure". How bad could this be? Well, he told me when he arrived home, "I'll never go on another hog hunting trip with your dad!"

He said, "He run me day and night all weekend. Especially all night. He'd run through them woods chasing them dogs and chasing them hogs and them wild boar down and he'd shoot one and throw it over his shoulder and walk out of those woods like he was a 20-year-old man."

He said, "It's going to take me a week to rest up from this hog hunting trip!"

Fast forward to 1989. Dad wasn't feeling very well at all but still wanted to go hog hunting. He was sick, but My dad wanted to hunt. He was the only one of that group that killed a hog that weekend, the last weekend he ever went hunting.

The photo with this story is of Dad and a hog that he killed on one of his last hunts with his friends. He passed from this life doing one of the things that he truly loved.

My grandfather Reuben Corbitt was a pretty good Hunter as many of you know too. I would surely imagine that Grandpa was the one that taught Daddy to hunt. And maybe they're hunting together right now. Archie Eugene Corbitt passed away on December 19, 1989.

My husband Wayne passed in 2011 after almost 38 years of marriage. We never lived in Alva but I spent half my childhood there. My family moved to Buckingham but every weekend and every holiday I and all my cousins were always at Grandpa's in Alva. Our whole family was very close and every Sunday all dad's siblings and my cousins had dinner under the big oak in Grandpa and Grandma Corbitt's front yard on Packinghouse Road.

Today Sandra Corbitt-Burdick spent her earliest years in Alva, and now lives near Lake Seminole, Georgia. She still maintains close ties with friends of her childhood along the Caloosahatchee River and everywhere she has lived.

In response to the numerous children killed in hit and run accidents in Lee County, Shield 4 Kids partnered with the community to paint benches to be placed at local bus stops.

The lack of sidewalks and street lights in Lee County have lead to an alarmingly high number of children killed in hit and run accidents.

The latest victim, was 14-year-old Allana Staiano.

“There’s nowhere near enough lights...the cars don’t slow down around here, they are very fast...they don’t pay attention, and there are not enough lights,” said Heather Atwood.

Young people say they are taking a stance against reckless drivers.

“People don’t watch out for little people when they’re driving also,” said Damion Lord.

“There should be more safety for kids...because its super sad when they get hurt,” Savannah Atwood.

One volunteer urges drivers to slow down in neighborhoods, and children to stay aware.

“Pay attention because bad things can happen even on a good day,” Michael Driekorn.

The organization Shield 4 Kids says this event was just a start, there is still so much more to be done to ensure the safety of our children.



A bit of ALVA History

ALVA is home to a major league ball player and current business leader

Mike Greenwell was born in Louisville, Kentucky. When he was five years old, his family relocated to Fort Myers, Florida; he would later attend North Fort Myers High School, where he played both baseball and football.

Greenwell was drafted in the third round of the 1982 Major League Baseball Draft by the Red Sox, and was signed on June 9, 1982.

On September 14, 1988, Greenwell hit for the cycle, becoming the 17th player to do so in Red Sox franchise history. On September 2, 1996, the Red Sox beat the Seattle Mariners 9–8 in 10 innings at the Kingdome, with Greenwell driving in all nine runs for the Sox, a record for most runs driven in by one player accounting for all of that team's runs in a single game. He also holds the American League record for most game-winning RBIs in a single season, with 23 in 1988; the game-winning RBI has since been discontinued as an official statistic. Greenwell was inducted to the Boston Red Sox Hall of Fame in 2008.

Following his American pro ball career Mike played professionally in Japan, then did some coaching back in the states. Upon his retirement from baseball, Greenwell began driving late model stock cars at New Smyrna Speedway, winning the 2000 Speedweeks track championship. In May 2006, he made his Craftsman Truck Series debut at Mansfield Motorsports Park for Green Light Racing, starting 20th and finishing 26th. In 2010, Greenwell gave up racing.

Today Mike Greenwell owns a 890-acre ranch in Alva, Florida, on which he grows fruits and vegetables. He owned an amusement park in Cape Coral, Florida, called "Mike Greenwell's Bat-A-Ball & Family Fun Park", which opened in February 1992 and was later sold.

Greenwell's wife Tracy is a nurse, and they have two sons, both of whom Greenwell coached to young careers in college and minor league baseball.

Today the Greenwell family owns and operates ROUTE 31 Produce and Mining, located at the intersection of route 78 and 31 just north of the Sweetwater Marina. The pandemic has hit this business as hard as any, but their website says new outdoor seating, a full menu, and lots of new items are available to purchase. A FREE MAKE-OVER FOR YOUR HANDS!

Does this seem like an advertisement? I found the solution for wrinkled hands quite by accident. Yes, I thought those wrinkles were the price I paid for my nursing career. Frequent hand washing in the hospital was my way of life for over 30 years. Lotion was a temporary fix until recently.



In April, during a routine appointment, the doctor questioned my elevated blood pressure. She thought it could be more than white-coat hypertension. Combined with high cholesterol and lower than normal kidney function (borderline stage 3 kidney disease), she advised checking my blood pressure frequently.

Shockingly, my morning blood pressure was 164/80 at highest. I decided to seek a second opinion from a nephrologist at Cleveland Clinic in Weston Florida. A

nephrologist is an M.D. that specializes in care of the kidneys, who also is competent in difficult-to-treat high blood pressure. I immediately (same day) had a virtual visit with a wonderful physician named Dr. Diane Sandy. Her orders were for a blood pressure medication called Amlodipine, decrease my caffeine consumption to two cups at most per day, drink at least 50 ounces of water daily, and have some blood tests and a renal ultrasound.

I was excited to have a plan of action and followed her orders perfectly. I changed my diet to less eggs and more fiber such as oatmeal and bananas. I didn't care for water but was able to doctor it up with frozen lemons, limes and stevia for sweetness. Now I love water! After 3 days on the medicine with all my other changes, my blood pressure dropped to 96/60. I also employed deep breathing exercises and meditation (PRAYER) which immediately lowers blood pressure.

My tests all came back normal so I am doing great. I feel like I have been given a second chance to take care of my body. The hardest part is trying to lose weight and exercise, but that is my long term goal. *So what is the FREE makeover for your hands?* A wonderful side effect of being hydrated is WRINKLE FREE hands and legs! My face may be a little better as well. If water works this well for skin, just imagine what it does to the interior of our bodies!

Remember summer is here and hot weather is a great set-up for dehydration, heat exhaustion, and possible heat stroke. Drink plenty of water unless contraindicated by a medical condition. Steve's Homemade Biscuits

2 c all-purpose White Lily flour

1 Tbsp baking powder

2 Tbsp sugar

1 tsp salt

8 Tbsp (1 stick) real butter (very cold)

3/4 c whole milk

Preheat the oven to 400.

Line a cookie sheet with parchment paper or use a silicone mat.

Combine dry ingredients and set aside.

Grate the cold butter and add to the dry ingredients.

Add the milk and combine with a wooden spoon or silicone scraper.

Do not overwork! When dough is cohesive, place it on a floured surface. Fold the ball in half and with hands (NO ROLLING PINS), flatten, turn dough 90 degrees, fold in half again and repeat this process 5 or 6 times. Then flatten to 1 inch thick. Dust a biscuit cutter with flour and press straight down (DO NOT TWIST IT) and put biscuits on cookie sheet. Bake at 400. Check them at 10 minutes-usually takes about 12 minutes depending on oven.





ALVA Garden Club NEWS



Jan Blythe and husband Jim moved from Miami to Fort Denaud on the shores of the Caloosahatchee River in 2014. She joined the Alva Garden Club in 2016. Jan is an active member of the club's landscaping committee that is responsible for watering, clipping, weeding, and planting on the grounds of the Alva Library and Museum.

The committee is in the process of designing and planting new flower beds, so this is an exciting time for the club and the public who will soon be able to enjoy the beauty of the grounds as well as the museum itself.

Jan has an unparalleled gorgeous garden at her own home, and she works daily to keep everything blooming and alive. She has many varieties of croton, bromeliad, ginger, coleus, hibiscus, canna lily and begonia in beautiful colors. She also has large specimens such as the pagoda plant, crepe myrtle, many fruit trees, and the Australian tree fern.

One of the most interesting plants in her garden is her caladium collection. The white Moonlight variety is pictured here and Jan reports that she has had great success with it each year. Caladium is an outstanding plant that is a fast grower anywhere in South Florida. The leaves die back in late fall as cooler weather begins and re-emerge in late spring.



Caladiums grow very well in a partial to full shade garden. An ideal location provides a bit of morning or late day sun and not much more than dappled sunlight during the afternoon. Most plants range in height from 1 to 2 feet.

Peak performance for caladiums lasts several years, then the leaves tend to be smaller. You can freshen a caladium bed by interplanting with new ones but digging up the old tubers and starting over gets the best results, as Jan has found. Most caladiums tubers used worldwide are produced in Florida.

Lake Placid-Sebring area is known as the Caladium Capital of the World and offers an annual Caladium Festival in July each year (this year's is unfortunately canceled). Jan has visited the festival and reports that it is a worthwhile and enjoyable experience!

The Alva Garden Club will have its first regular meeting of the 2020-21 year in October, provided the Alva Library and Museum is open and we are past the Covid-19 pandemic. The new board of officers is planning exciting programs and speakers. Club meetings will be posted on the website:





Florida Forest Service Reopens Additional Recreation Areas, Moves to Cash-Free Point-of-Sale System

Tallahassee, Fla. — As Independence Day approaches, Agriculture Commissioner Nikki Fried and the Florida Forest Service announced that additional Florida State Forest recreation areas are reopening as they move to an online, cash-free point-of-sale (POS) system.



“As we reopen additional Florida State Forest recreation areas, we encourage everyone to be cautious during COVID-19 and to take advantage of our state’s natural treasures responsibly,” said Commissioner Fried. “The online, cash-free sale system will help everyone safely enjoy all that our Florida State Forests have to offer, including trailheads, campsites, and off-highway vehicle areas.”

Dates you need to know:

June 24: Annual Off-Highway Vehicle (OHV) passes will be available for purchase. Passes are valid for the 2020-2021 fiscal year, which begins July 1, 2020 and ends June 30, 2021.

July 1: Day-use passes for recreation areas, including trailheads and OHV riding areas, will be available for purchase.

July 10: Group campsites, picnic pavilions and group recreation areas will reopen with a capacity limit of 50 people.

“We look forward to transitioning Florida State Forest recreation sales to a digital platform,” said Erin Albury, State Forester and Director of the Florida Forest Service. “The online system not only streamlines the payment process for Floridians and visitors but reduces the risk of spreading COVID-19.”



Practicing Water Safety Is Important to Everyone

Summer is here. That means people will be having a good time on the water—whether it's swimming or being on some kind of boat! Lee County has one of the highest numbers of boat-related deaths in the state. The Injury Prevention Coalition of Lee County reminds everyone that water safety should be practiced.

In 2012, 71 percent of all fatal boating accident victims drowned, and of those who drowned, 85 percent were not wearing a life jacket. Drowning is the leading cause of injury-related death among children between one and four years. It's the third leading cause of death among children. Here are a few basic tips from Safe Kids Worldwide to keep you safe:

- Teach children how to swim, tread water, and float.
- Teach children that swimming in open water is not the same as swimming in a pool.
- Teach children how to swim in case they're caught up in a rip tide.
- Always wear a life jacket when on boats, around open bodies of water.
- Make sure the life jacket fits properly.
- Babies should not travel on a boat until they are the appropriate weight to wear an approved life jacket.
- Swimming aids such as water wings or noodles are fun toys but should not be used in place of life jackets.
- Get a vessel safety check each year for free from the U.S. Coast Guard Auxiliary or U.S. Power Squadron.

A large portion of boating accidents involve alcohol consumption so neither boat operators nor passengers should drink. It would be wise to learn CPR. Teach children not to dive into bodies of water because you never know what might be hidden under the surface.



Every child is different but they should never be left alone in or around water. Babies can drown in as little as one inch of water.
